## 2022 MEDICARE NUMBERS

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2022:

\*Note that individuals with annual incomes over \$91,000 and married couples with annual incomes over \$182,000 will pay a higher Medicare Part B Premium.
